- 3) I undertake and agree to remove myself from participation if I sense or observe any unusual hazard or unsafe condition, or if, at any time, I feel unable or unfit to safely continue for any reason. I also understand that the Town of Middleton has the right to refuse me use of the equipment based on safety. This includes but is not limited to: Suspected drug or alcohol consumption, inclement weather conditions, unsafe river conditions, physical fitness not suitable for activity.
- 4) I agree to use and preserve the equipment in a careful and proper manner and shall return it in the same condition that it was received in, reasonable wear and tear excepted.
- 5) I confirm that I have fully inspected the equipment to be rented hereunder and acknowledge the equipment is in good condition and repair, and is suitable for the intended purpose.
- 6) I understand that the Town of Middleton makes no representations of warranties with respect to the reliability or durability of the equipment beyond normal and reasonable use.
- 7) I acknowledge and agree that the Town of Middleton is not liable for any loss, damage, injury or expense of any kind associated with my use of the equipment, whether suffered or incurred by my self or any third party, and I hereby specifically agree to both render and save harmless the Town of Middleton from all such expenses and claims and to make no claims or demands or any nature or kind against the Town of Middleton in this regard.
- I agree to pay the Town of Middleton for any loss or damage to the equipment associated with my use of the equipment, including the cost of replacement if necessary.
