- On Sunday July 26th we had our Seniors Celebrations event, sponsored by Subway. The forecast
 was calling for rain, but we still had a good turnout. Rachel MacLean performed on the piano, a
 favorite of the seniors who attend. Subway provided the sandwiches, coffee, tea, and cookies
 for the event, and all had a good time!
- August 8th was our first annual Heart Run. We offered a 5k, 10k, and 25k run. With a turnout of about 75 runners, we were very happy with the results of this event and look forward to being able to offer it again next year.
- August 9th, 2015 marked the 7th edition of the Heart of the Valley Century Ride. This year's edition of the Ride set a new record for registrants, with approximately 410 cyclists coming to our town from all four Atlantic provinces, Quebec, Ontario, Alberta, multiple US states, and a family from the Middle East! The Century Ride has grown steadily the past three years, and would not be possible without the generous contributions of local businesses. Cyclists received a custom jersey from Louis Garneau featuring Middleton and Nova Scotia, food stops along the route, a delicious chicken dinner provided by the Fire Department, and live entertainment by the Hupman Brothers. We received many positive comments from attendees who are already looking forward to next year!
- Our Movies in the Park have continued every Friday night at Centennial Park all summer, with
 the number of attendees growing each week. Investors Group sponsors the Movie series, and
 each movie has some fun pre-movie entertainment for the family while we wait for the sun to
 set, such as dance parties, free face painting, games, and fun runs. Our August 14th movie will
 feature the Greenwood Players performing our Play in the Park before the movie begins, a free
 family play that was rescheduled after being rained out on July 26th.
- We have two weekends left of events to wind down the summer. August 14th-16th features our Movie in the Park (Harry Potter, which matches the Day Camp theme of the week), and our Picnic in the Park. The Picnic is a free BBQ in Centennial Park on Sunday afternoon, with burgers, hot dogs, fruit, drinks, a bounce castle, face painting, washer toss, and of course our splash pad! The Margie Brown Duo will also be performing. August 21st will be our Summer Shutdown Party, which will have a free pool party Friday night from 6:30 8 PM, followed by our last Movie in the Park, Kung Fu Panda.

- We have only a week and a half left of our day camp program. We have had a very successful summer and we would like to thank our camp staff for doing such an amazing job making sure that we are providing a fun and safe environment for all our participants. We would also like to thank the Middleton Fire Department for the use of their hall, the Middleton Rink Commission for the use of the rink, and both schools for allowing us the space to conduct our programs.
- Our senior fitness, yoga, and boot camps programs are all on-going and will continue until the
 end of August. We are in the process of organizing our fall programs and hope to be able to
 offer these programs and more. If there is any program that you would like to see happen and
 you are willing to help get it off the ground, we are always open to trying new things.
