

**CHAPTER 58
REPEAL OF BYLAWS
TOWN OF MIDDLETON**

BE IT ENACTED by the Council of the Town of Middleton, under the authority of the *Municipal Government Act*, as follows:

1. SHORT TITLE


This Bylaw shall be known as Chapter 58 and may be cited as the “Repeal of Bylaws Ch 58”.
